## Securisyn Medical Commitment to Action

Securisyn Medical is pleased to announce their support of the Patient Safety Movement Foundation (PSMF) and its mission to eliminate preventable deaths by 2020 (~~oX2020~~).

Securisyn Medical is a development stage medical device company driven by the clear mission to make airway management safer through innovation, education, and collaboration. With a vision toward a world in which the complications of airway management no longer exist, Securisyn is working on design concepts and products intended to address a wide range of complications of advanced airway management which result from failed intubation, mal-positioned intubations, pressure injuries and post intubation migration of the endotracheal tube. A complication of airway management, known as unplanned extubation, is responsible for over 12,000 preventable deaths in the US every year. Unplanned extubation is the unintentional removal of a life sustaining breathing tube and is a direct result of inadequate stabilization. Securisyn Medical is currently working with the FDA to obtain market clearance on its SolidAIRity Airway Stabilization System, which securely stabilizes a patient's airway by restraining against significantly greater forces than competitive devices currently on the market, with the goal of significantly reducing the number of preventable deaths caused by unplanned extubation.

As a committed organization, Securisyn Medical will demonstrate partnership with the PSMF by:

1. Spreading the Patient Safety Movement Foundation's mission of reducing preventable patient deaths. Specifically, Securisyn will collaborate with the PSMF to educate its partners on patient safety issues during airway management and will work tirelessly towards achieving the goal of zero preventable deaths by 2020 from unplanned extubation.
2. Recruiting applicable members within Securisyn Medical's network to participate in the Patient Safety Movement Foundation's Airway Safety workgroup to ensure PSMF's Actionable Patient Safety Solutions (APSS) represent best clinical practices to date and show case a diverse group of experts.
3. Asking hospital organizations working with Securisyn Medical to make a Commitment to a patient safety initiative or process, whether that be one aligned with the Patient Safety Movement Foundation's 13 core challenges or an alternative challenge they wish to share with the Movement's network of partners.
